# **Speakers**



**Dennis J. Broderick** is Executive Vice President, General Counsel, and Secretary of Macy's, Inc., a position to which he was elected in May 2009.

Broderick joined the company in 1987 when he was appointed vice president and deputy general counsel. He was named senior vice president and general counsel in 1990 and secretary in 1993.

Before joining Macy's, Broderick was assistant general counsel at The Firestone Tire & Rubber Co. in Akron, Ohio. Prior to that, he practiced with the law firm of Hahn, Loeser, Freedhaim, Dean & Wellman (now Hahn, Loeser & Parks) in Cleveland, Ohio.

Broderick is a member of the CBA-BLAC Roundtable. He is a former at-large vice president of the Leadership Council on Legal Diversity Board of Directors and a former member of the Cincinnati Symphony Board of Trustees.

A native of Pittsburgh, Broderick is a graduate of the University of Notre Dame. He earned his law degree from the Georgetown University Law Center in 1976. He lives in the Cincinnati area.



**Kendric Cobb** serves as Corporate Counsel at Caterpillar Inc. in Peoria, Illinois. He has been with Caterpillar since 2008 and has been a leader in the company's award winning Pro Bono Program. After working in the Litigation Section of Caterpillar's Legal Services Division, managing a wide range of product, commercial, and mass tort litigation, Cobb transitioned to the Employment Practice Section at Caterpillar, where he provides advice and counsel on all areas of employment law, internal

investigations, and regulatory compliance in the U.S. and Canada. In addition, Cobb manages a litigation docket comprised of employment and commercial matters.

Prior to his career at Caterpillar, Cobb was a commercial and regulatory litigator in the Chicago offices of three law firms: Winston & Strawn, LLP, Butler Rubin, LLP, and Reed Smith, LLP. Cobb has served on the Board of Directors of the Illinois Equal Justice Foundation, a legal aid funding foundation, and The Crittenton Centers, a crisis nursery and child development center. He is also a former director of the Cook County Bar Association, the oldest organization of African-American lawyers and judges in the country.

Cobb is a native of Champaign, Illinois, and is a graduate of both the University of Illinois at Urbana-Champaign and the University of Illinois College of Law. In his spare time, he enjoys live concerts, live sporting events, and working with youth.



Chris De Santis is an independent consultant specializing in the design and delivery of management and organization development interventions.
