\$5,000 in the form of W-2 compensation, or a direct-payment of tuition and/or academic fees, after successfully completing the summer associate program and agreeing to return for a second summer. An additional \$5,000 will be paid after the second summer upon acceptance of a position as an entry level attorney.
