## Cooley LLP | Boston

Visitors must attest (verbally) that they are **fully vaccinated** and at least two weeks past their second dose. *Health questionnare required upon arrival.* 

#### Sidley Austin LLP | Los Angeles

We require that everyone coming into the office be **fully vaccinated**. For these purposes, "fully vaccinated" means vaccinated for at least 14 days after completion of a two-dose Pfizer or Moderna vaccine or a one dose J&J vaccine.

We require proof of vaccination in advance to accommodate the size of the group and/or facilitate an otherwise efficient check-in process. The copy you send of your vaccination card or CA state-issued vaccination QRG record will be handled by our Human Resources Department and, once listed as a vaccinated visitor, will be deleted. We maintain the list otherwise for contact tracing capability, should it become necessary, as well as for additional future visits you may have with us. Proof of vaccination can be sent to ladowntownreceptionist@sidley.com.

## Bradley Arant Boult Cummings LLP | Nashville

No vaccination requirements.

### Dentons | Atlanta

All visitors must be **fully vaccinated** to enter the office. Fully vaccinated means it has been two weeks after your second dose in a two-dose series, such as the Pfizer or Moderna vaccine, or two weeks after a single-dose vaccine, such as the Johnson & Johnson vaccine. *Health questionnaire required prior to arrival.* 

# Crowell & Moring LLP | Chicago

Visitors must be **fully vaccinated**, including one booster before they may enter Crowell & Moring. *Health questionnaire required prior to arrival.* 

# Dechert LLP | New York City

All vendors and visitors are required to be vaccinated; vaccine proof may be shown via an app, photo



or vaccine card upon arrival.

The Receptionist will ask to see *verification of vaccine status upon arrival*. The firm will not retain copies of any visitor's or vendor's vaccine information. Unvaccinated people should not attend.

Everyone is highly encouraged to wear masks in all public indoor settings, including the building elevators and all public areas of the office. However, masks are not required.

#### Venable LLP | Washington, D.C.

Effective September 13, 2021, anyone entering Venable offices must be **fully vaccinated**. "Fully vaccinated" means that two weeks have passed since receiving the second dose in a 2-dose series such as the Pfizer or Moderna vaccines or two weeks have passed since receiving a single-dose vaccine such as Johnson's Janssen vaccine.

Upon arrival at our office, all visitors will be expected to complete an attestation. A completed attestation will be required each day you are visiting Venable. If you are not fully vaccinated, you will not be allowed into our offices and should make alternative plans to meet with your Venable host.

We appreciate your willingness to work with us to maintain a safe environment and I encourage you to let me know if you have any questions with regard to our protocols. *Attestation required upon arrival*.
