RICK HAMMETT is Managing Partner of the North America region for Baker & McKenzie LLP. Immediately prior to assuming the NA MP position, he was Managing Partner of the Houston Office. He has also been the chair of the North America Compensation and Employment Practice Group, and a member of the Global Steering Committee for the Global Employment Practice Group. He has served on the North American Regional Council continuously since he join Baker & McKenzie in 1999
