MATT COOPER is General Counsel of Capital One Financial Corporation. He reports directly to Capital One Founder, Chairman, and CEO Rich Fairbank and is a member of the company's Executive Committee.

In his role, Cooper leads a legal department of 350 attorneys and legal professionals supporting all of Capital One's lines of business globally.

Cooper joined Capital One in January 2009. Before assuming the role of General Counsel in 2018, he held various leadership roles within Capital One's Legal Department, including serving as the Head of Litigation and as Chief Counsel for the company's Global Credit Card Division.

Prior to joining Capital One, Cooper held executive positions in the legal department of General Electric Co., as well as serving as Deputy General Counsel of GE Capital's successor company, Genworth Financial. Cooper joined GE from McGuireWoods, LLP.

Cooper serves on the boards of several community organizations, including the Leadership Council for Legal Diversity and Venture Richmond.

Cooper obtained a B.A. with High Honors and a J.D. from the University of Virginia, and clerked for David M. Ebel of the U.S. Court of Appeals for the Tenth Circuit.
