**PHILIP F. SUSE** advises prominent clients across a broad range of industries public utilities, manufacturing, petrochemicals, and airline, among others—in connection with their acquisition and divestiture activities in the U.S. and abroad. This includes joint ventures, securities offerings transactions, securities compliance and corporate governance matters, and other corporate transactions. He is a former Managing Partner of the firm's North America region and a current member of the firm's Executive Committee. He was also the chairman of the firm's North America Corporate and Securities practice, as well as a member of the Global

Mergers and Acquisitions Steering Committee.

Suse is a member of the American Bar Association and the Illinois State Bar Association. He is also a member of the Board of Directors of LINK Unlimited, which provides educational college preparatory opportunities for economically disadvantaged African-American high school youth.

Suse earned a J.D. and an M.A. from the University of Pennsylvania in Philadelphia, PA (1981, 1978). He received a B.A., summa cum laude, from the College of the Holy Cross in Worcester, MA (1976) and was an ITT International Fellow at the University of Riyadh (now King Saud University) in Riyadh, Saudi Arabia (1977). Suse is admitted to practice in Illinois.





**DARRYL BRADFORD** is the Senior Vice President and General Counsel of Exelon Corporation, where he is the primary legal advisor to Exelon's senior management and oversees the company's legal and corporate governance departments. Exelon Corporation is the leading U.S. competitive energy provider with approximately \$25 billion in annual revenues. Exelon Generation is one of the largest competitive U.S. power generators, with approximately 35,000 megawatts of owned capacity comprising one of the nation's cleanest and lowest-cost power generation fleets. The company's Constellation business unit provides energy products and services

to approximately 100,000 business and public sector customers, and approximately 1 million residential customers. Exelon's utilities deliver electricity and natural gas to approximately 6.6 million customers in central Maryland (BGE), northern Illinois (ComEd), and southeastern Pennsylvania (PECO).

Prior to his current appointment, Bradford served as Senior Vice President Energy and Regulatory Policy and General Counsel for Commonwealth Edison, a subsidiary of Exelon. Before joining ComEd, Bradford was a senior partner at the Chicago office of Jenner & Block, where he served on the firm's Management Committee, as co-chair of the firm's Litigation Committee, and cochair of the telecommunications practice, advising clients on issues associated with the transition to a competitive marketplace. He practiced at Jenner & Block for more than 20 years where he tried both civil and criminal cases and argued numerous cases before the United States Courts of Appeals and state appellate courts.

Prior to joining Jenner & Block, Bradford clerked for the Honorable Bernard M. Decker of the United States District Court for the Northern District of Illinois. He is admitted to practice law in the State of Illinois, the United States Supreme Court, and several United States Courts of Appeals and federal district courts.

Bradford serves on the Board of Directors of Energy Insurance Mutual. He is also a Trustee for the Kohl's Children Museum, the Ravinia Festival, and the Constitutional Rights Foundation. He serves as Chair of the Edison Electric Institute's (EEI) Subcommittee on Corporate Issues and on EEI's Legal Planning Committee. Bradford is a member of Leadership Council on Legal Diversity and the North Shore General Counsel Association.

Bradford graduated from the University of Chicago Law School in 1980 where he served as an editor on the Law Review. He received his bachelor's degree, Phi Beta Kappa, from Grinnell College in Grinnell, Iowa in 1977.
