What is a Learning Experience?

Learning Experiences (LEs) are 1- or 2-day events hosted by LCLD Member Corporations. They offer an insider's look into the organization's business, legal departments, and/or leadership structure. Typically hosted by the organization's General Counsel or Chief Legal Officer, LEs often include sessions with other

business leaders such as CEOs, CFOs, and Compliance, Marketing, and DEI Professionals to name a few. Attendees will leave with an understanding of the business and the link between their legal knowledge and the outcomes coveted by the business leaders. They may also bring back new DEI ideas to their own organizations and strengthen their relationships among their Fellows cohort.

Who can attend?

Current Fellows who have not attended a previous LE are given priority on a first-come, first-served basis. However, current Fellows who *have* attended another LE, as well as LCLD Alumni, may also attend. Each LE is capped at about 35 Fellows, and spots not taken during the priority period will be filled by "repeat offenders." Most LEs have attendees among this group.

Where do LEs take place?

LEs can take place anywhere the LCLD Member corporation host has an office. Most hosts hold their LEs at their headquarters, but some may choose other locations based on their size, location of leadership, and ease of travel.

How do I attend an LE?

Each LE will have an event page on the LCLD Events Calendar. Check the calendar and the weekly *#TalentRising* newsletter often for upcoming LEs. The RSVP process is automated and typically opens 6-8 weeks prior to the event. Since space is limited, only those planning to attend should sign up. Once you have registered, a LCLD staff member will be in touch (usually within a couple of days) to confirm whether you have made it on the attendee list or wait list. There is no registration fee, but the cost of travel and hotel is the responsibility of each attendee.
